No Wood Packaging	Shipments that are international only and dispatched from the US with a destination country of China.
Pack Slip	Always produced (if set up).
Packing Pack Slip	Must be mapped and called manually using a PierbridgePackItemPrint request.
PAPS Manifest	End of Day for FedEx Express shipments.
Placeholder Document	Always produced if a batch transaction fails and the request would otherwise have printed a document.
Proof Of Delivery	Always produced (if set up).
Radiation Reduction	Never automatically generated. Should be requested when required.
SED	<ul style="list-style-type: none"> <li>Shipments that are international only and dispatched from the US.</li> <li>Any package in the shipment must have a content value greater than 2500.</li> <li>The shipment must have a destination country of one of the following: Cuba, Iran, Iraq, Libya, North Korea, Serbia, Sudan or Syria.</li> </ul>
